## Requirements and Procedures for Designated REALTOR® Members

- 1. You must be a licensed broker or certified or licensed appraiser in Wisconsin.
- 2. To apply, fill out an "Application for Membership" and return to the GMAR Membership Processing Center with application fee and prorated dues (based upon your date of licensing).
- 3. Once the GMAR has received your information, MLS will be electronically notified within 24 hours. Please contact MLS at 414-778-5400 to get membership, training and login information.
- 4. Within 1 week, you will receive information from the GMAR regarding our mandatory orientation. After receiving that information, please contact the GMAR to sign up for a class. Orientation is required by the National Association of REALTORS® and is a pre-requisite to membership. You have 3 months to complete this free class! Non-compliance will result in the suspension of services and require the payment of an additional \$270. Upon completion of orientation, your application will be submitted to the Board of Directors for approval.
